INTRODUCTION

INTRODUCTION TO THE NRF

The National Research Foundation Act as amended, Act 19 of 2018, establishes the National Research Foundation ("NRF") as the juristic legal entity that will contract with the awarded bidder. Please visit the NRF website (https://www.nrf.ac.za) for more information.

BACKGROUND TO SAEON

The South African Environmental Observation Network (SAEON) is a business unit of the National Research Foundation (NRF). SAEON comprises a diverse research infrastructure with the core objective of being a long-term monitoring platform for biospheric data and the strategic aim to investigate global change drivers and anthropogenic impacts on socio-ecological security of South Africa's ecosystems. Further information about SAEON can be found on www.saeon.ac.za

THE NEED FOR THIS PROCUREMENT WITHIN SAEON

Digital action cameras are used in image-based data collection in Benthic Ecosystem Long-Term Ecological Research (BELTER). The cameras are deployed in mono or stereo configuration on underwater equipment frames and are referred to as stereo Baited Remote Underwater Video (sBRUV) and Jump Camera (JC) systems. The new equipment will be used for the collection of long-term data from SAEON Shallow Marine and Coastal Sentinel sites and Satellite Sentinel sites including marine protected areas along the South African coast. Data collected is used to further our understanding of biodiversity in maintaining ecosystem functionality, and better understand the relationship between anthropogenic stressors and ecosystems and the response to Global Climate Change. The method of data collection, used by the SAEON Elwandle Coastal Node's Shallow Marine and Coastal Research Infrastructure (SMCRI)'s Benthic Ecosystem Long-term Ecological Research (BELTER) programme and aligns with Ocean Best Practices endorsed by the Global Ocean Observing System (GOOS) initiative.

The current video infrastructure

The current video infrastructure makes use of the GoPro Hero Black (5 and 7) suit of cameras and accessories. The new equipment should improve on and be compatible with the existing infrastructure and compatible with the analytic, annotation software (SeaGIS Transect Measure, Event Measure and CAL (https://www.seagis.com.au/) in use.

THE REQUIREMENT OF THIS BID

SAEON Elwandle Coastal Node (also referred to as the Node) in support of ongoing coastal marine research require the supply and delivery of camera equipment and accessories to be used as part of its BELTER infrastructure.

EQUIPMENT AND/OR SERVICES REQUIREMENT SPECIFICATIONS

The suppler must be able to supply camera equipment and accessories to the SAEON Elwandle Coastal Node at the Ocean Sciences Campus, Nelson Mandela University, Gqeberha (Port Elizabeth) as ordered and when required for the duration of the contract.

THE SUPPLIER MUST BE ABLE TO SUPPLY AND DELIVER CAMERA EQUIPMENT AND ASSESORIES WITH THE SPECIFICATIONS OUTLINED BELOW:

1. Action camera specifications:

All action cameras and accessories meet the following minimum specifications set out below.

- 1.1 Cameras can produce at least 23 Megapixel Raw image files.
- 1.2 Cameras have CMOS sensor with at least 4K Ultra HD recording allowing to obtain at least 15 Megapixel stills images from video.
- 1.3 Option of 30 and 60 Frames per Second (FPS) when recording video at a resolution of 1080p.
- 1.4 Simple one-button recording control option.
- 1.5 Touchscreen.
- 1.6 Waterproof up to at least or more than 9 meters (30ft) without additional housing.
- 1.7 The camera must allow for the enabling and disabling of (to switch on or off the) stabilization, Wi-fi, GPS and screen rotation functions of the camera.
- 1.8 Camera must run continuously for a minimum of at least 80 minutes (at 1080p/30fps) on a single battery supplied by the bidder.
- 1.9 The camera does not exceed the following external dimensions: 75 x 55 x 35 mm.
- 1.10 If the camera itself is not rated for deep diving of up to or more than 60 meters (196 ft) depth, then the camera should fit snugly and securely into an underwater housing rated for deep diving of up to or more than 60 meters (196 ft) depth.
- 1.11 The camera uses a MicroSD card for data storage (with the capacity to operate with a 64GB MicroSD card).
- 1.12 Batteries must be removable, not built-in, and chargeable in an external charger.
- 1.13 The camera includes a digital lens that captures a wide field of view NOT ONLY super wide, linear or narrow.

2. Specification for clear underwater dive housings:

- 2.1 If the camera itself is not rated for deep diving of up to or more than 60 meters (196 ft) depth waterproof housings must be provided.
- 2.2 The waterproof housing must fit the action cameras securely and snugly and prevent movement of the action camera within the underwater housing.
- 2.3 The clear waterproof housing allows for the use of the camera buttons (camera on/off and record on/off) when the camera is in the underwater housing.
- 2.4 The clear waterproof housing is rated for deep diving to a depth of up to or exceeding 60m

(196ft).

- 2.5 The clear waterproof housing has a flat glass lens/window to deliver maximum image sharpness above and below water.
- 2.6 The display screens of the camera as specified above are clearly visible through the underwater housing.

3. Specifications for 64 GB micro SDXC memory cards:

- The card has a minimum of 64GB storage capacity with up to or more than 45 MB/s write and read speed.
- 3.2 The card is classified with C10, U3, V30 video speed category A2.
- 3.3 Designed to withstand water, temperature, shock, and X-rays.
- 3.4 Operational temperature range of at least -5 to 50 degrees Celsius.

4. Specification for Battery Charger:

- 4.1 Certified to charge lithium-ion rechargeable batteries.
- 4.2 Charge at least two batteries simultaneously. Charger to USB-A charging cable included.

5. Specification for Rechargeable batteries:

5.1 Able to power the action camera to record video continuously for or exceeding 80 minutes video.

6. Compatibility to equipment in use by SAEON Elwandle Coastal Node

When needed and for the purpose of the replacement of equipment/accessories already in use by SAEON the make and model of the equipment/accessories will be specified.

7. Associated accessories

7.1 "Associated accessories" means for the purpose of this document all accessories that are provided standard with the camera, those in the box with the camera including a battery, mounting frame, adhesive mounts, mounting buckle, USB-C cable, and thumb screw. It also includes additional equipment listed above such as the clear underwater housings, memory cards, dual battery chargers, and extra rechargeable lithium-ion batteries. All associated accessories must adhere to the specifications as set out above.

8. Evidence of meeting the specifications

- 8.1 Detailed specifications sheets must be provided for the equipment offered in response to the specification in this invitation.
- 8.2 Full list of accessories included standard with the camera (e.g., camera housing, adhesive mounts, and cables) must be provided.

9. Value-added services (for additional requirements see GCC13 and GCC14 p.16)

9.1 The appointed bidder provides the original equipment manufacturers (OEM) service and maintenance schedules as designed by the OEM over the life of the equipment offered.

10. Acquisition of units (years 2 to 5)

Bid Number: NRF/SAEON SMCR/39/2022-23

10.1 The Node reserves the right to obtain three quotations to test the market pricing offered by the appointed bidder.

11. Warranty (also see GCC15 p.17)

- 11.1 The equipment and accessories should have a minimum warranty of twelve (12) months for any manufacturing defects which obliges the repair or replacement of defective parts or product.
- 11.2 The appointed bidder must manage the warranty claim, process on behalf of SAEON, assist in identifying what is claimable as warranty repair and assist in repairing where not a warranty claim at no cost to the Node during the period of warranty to correct the manufacturer's fault if these arise in the operation.
- 11.3 Cameras and parts not functional will be sent back to the supplier immediately upon noticing the fault for the supplier to send to the manufacturer to check, fix or replace while under warranty.

12. Service and Maintenance documentation

- 12.1 The bidder is required to supply detailed operations and maintenance manuals and service schedules for all supplied goods. And to update such documents over the contract life where OEM/supplier has improved equipment or changed maintenance requirements.
- 12.2 The bidder is required to supply a list of all replaceable parts and components with part numbers.

13. Equipment testing (also see GCC8 p.14)

- 13.1 At the discretion of SAEON, SAEON may require the bidder to supply two camera units (camera, underwater housing, and accessories) for testing and evaluation (if so, requested by the Node) to determine if the proposed product meets the technical specification and is fit for purpose thus being admitted into the subsequent price competition.
- The supplier will supply these test units at the risk of the bidder and liability stays with the supplier as SAEON will not be held liable for any consequential damage during testing. If testing fails to show that the camera units and accessories are compatible with existing equipment and software and if found, at SAEON's discretion, not fit for purpose, the equipment will be returned to the supplier with an explanation of the aspects in which the equipment failed to fulfil the necessary requirements. The bidder and OEM representative can attend the testing. The bidder will be disgualified from further participation in the bidder selection process.

BIDDER REQUIREMENTS

1. Provide detailed requirements to evaluate the bidder's ability to deliver on the bid.

1.1. Bidders must provide the requisite documents that substantiate their responses to these specifications. For example; (i) Provide the Original Equipment Manufacturer (OEM) Technical Manual of the instrument being offered written in the English Language. ii) Provide the Original Equipment Manufacturers (OEM) service and maintenance schedules (in the English language) as designed by the OEM over the life of the equipment offered in response to the specifications

in this invitation. Provide any additional data/information sheets required in order to evaluate the specifications outlined in this BID.

2. Ethical requirements

2.1. The bidder must confirm that there are no interests with the NRF, has clean business practises, and has determined its bid independently from others as reflected on its submitted SBD 1, SBD 4, and SBD 6.1 forms.

CONTRACT PERIOD

The total contractual period for this bid is five (5) years commencing from the date of the final signature on the SBD 7.1 Contract Signing Form. The initial (year 1) supply and delivery of the cameras and accessories will be followed by a four (4) year contract for the supply of the additional cameras and accessories.

CONTRACT MANAGEMENT

- 1 Specify the method of delivery and conditions for determining successful delivery after contract (SBD 7.1) is signed
 - 1.1 The NRF appoints a contract manager and notifies the other party in writing of the name and contact details of the appointed contract manager.

2 Contract Manager

2.1 The Contractor appoints a contract manager and notifies the other party in writing of the name and contact details of the appointed contract manager.

3 Contract Communication

- 3.1 The NRF communicates in writing including through email.
- 3.2 The NRF maintains all contract documentation, and communications and correspondence, etc. for record purposes.
- 3.3 The NRF allocates the contract number with secondary reference numbers i.e. purchase order numbers and will inform the contractor of these numbers. The NRF will require any communication to contain the contract number.

4. Managing service levels

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words "department" means organs of state inclusive of public entities and vice versa, and the words "will/should" mean "must".

The National Research Foundation cannot amend the National Treasury's General Conditions of Contract (GCC). The National Research Foundation compiles separate Special Conditions of Contract (SCC) relevant to this bid where applicable supplementing the General Conditions of Contract. Where there is conflict, the provisions of the Special Conditions of Contract shall prevail.

- GCC 1 Definitions The following terms shall be interpreted as indicated:
- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown, or produced, or from which the services are supplied. Goods produced when, through manufacturing, processing, or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components
- 1.7 "Day" means calendar day.

- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods,

- epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" mean the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price, which is not included in the imported content if local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components, and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site", where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

GCC2 Application

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the

special conditions shall apply.

GCC 3 General

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 With certain exceptions (National Treasury's eTender website), invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za

GCC 4 Standards

4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

GCC 5 Use of contract documents and information

- The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure made to any such employed person is in confidence and shall extend only as far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

SCC5A Copyright and Intellectual Property

Intellectual property refers to creation of the mind, such as inventions; literary and artistic works; designs; and symbols, names, images used in commerce; and includes copyright (a legal term describing the rights that creators have over their literary and artistic works including books, music, paintings, sculpture and films, to computer programs, databases, advertisements, maps and technical drawings); trademark (a legal term describing a sign capable of distinguishing the goods or services of one enterprise from those of other enterprises); and patents (a legal terms describing an exclusive right granted for an invention providing the patent owner with the right to decide how - or whether - the invention can be used by others).

Background intellectual property is defined as the intellectual property pertaining to this contract and created and owned by any of the contracted parties to this contract prior to the effective date of this contract.

Contract intellectual property is defined as intellectual property created by the parties to this contract for and in the execution of the contract.

All background intellectual property (existing prior to this contract) invests in and remains the sole property of the contracted parties to this contract. Both parties disclose openly such intellectual property ownership to the parties in writing at the commencement of this contract.

The contracted party grants the NRF a fully paid up, irrevocable, and non-exclusive licence to use its background intellectual property for the exploitation of this contract to enable the NRF to obtain the full benefit of the contracted deliverables for this contract.

The parties agree that all right, title, and interest in contract intellectual property created during the execution of this contract invests with the NRF unless where agreed in writing to a different allocation of the ownership of the contract intellectual property with such allocation being an appends to this contract.

Both parties to this contract shall keep the intellectual property created during this contract confidential and shall fulfil its confidentiality obligations as set out in this document.

The contracted party agrees to assist the NRF in obtaining statutory protection for the contract intellectual property at the expense of the NRF wherever the NRF may choose to obtain such statutory protection.

The contracted party shall procure where necessary the signatures of its personnel for the assignment of its respective contract intellectual property to the NRF or as the NRF may direct, and to support the NRF or its nominee, in the prosecution and enforcement thereof in any country in the world.

The contracted party irrevocably appoints the NRF to be its true and lawful agent in its own name, to do such acts, deeds, and things and to execute deeds, documents, and forms that the NRF, in its discretion, requires in order to give effect to the terms of this clause.

SCC5B Confidentiality

The recipient of confidential information shall be careful and diligent as not to cause any unauthorised disclosure or use of the confidential information, in particular, during its involvement with the NRF and after termination of its involvement with the NRF, the recipient shall not:

- Disclose the confidential information, directly or indirectly, to any person or entity, without the NRF's prior written consent.
- Use, exploit or in any other manner whatsoever apply the confidential information for any other purpose whatsoever, other than for the execution of the contract and the delivery of the deliverables or
- Copy, reproduce, or otherwise publish confidentiality information except as strictly required for the execution of the contract.

The recipient shall ensure that any employees, agents, directors, contractors, service providers, and associates which may gain access to the confidential information are bound by

agreement with the recipient both during the term of their associations with the recipient and after termination of their respective associations with the recipient, not to

- Disclose the confidential information to any third party, or
- Use the confidential information otherwise than as may be strictly necessary for the execution of the contract.
- The recipient shall take all such steps as may be reasonably necessary to prevent the confidential information from falling into the hands of any unauthorised third party.

The undertakings set out in this clause shall not apply to confidential information, which the recipient is able to prove:

- Was independently developed by the recipient prior to its involvement with the NRF or in the possession of the recipient prior to its involvement with the NRF;
- Is now or hereafter comes into the public domain other than by breach of this contract by the recipient;
- Was lawfully received by the recipient from a third party acting in good faith having a right of further disclosure and who do not derive the same directly or indirectly from the NRF, or
- Required by law to be disclosed by the recipient, but only to the extent of such order and the recipient shall inform the NRF of such requirement prior to any disclosure.

The recipient shall within one (1) month of receipt of a written request from the NRF to do so, return to the NRF all material embodiments, whether in documentary or electronic form, of the confidential information including but not limited to:

- All written disclosures received from the NRF:
- All written transcripts of confidential information disclosed verbally by the NRF; and
- All material embodiments of the contract intellectual property.

The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract.

The recipient acknowledges that the unauthorised disclosure of confidential information may cause harm to the NRF. The recipient agrees that, in the event of a breach or threatened breach of confidentiality, the NRF is entitled to seek injunctive relief or specific performance, in order to obtain immediate remedies. Any such remedy shall be in addition to and not in lieu of any other remedies available at law, including monetary damages.

SCC5C Copyright and Intellectual Property

GCC6 Patent rights

6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

GCC7 Performance security

- 7.1 Within thirty days (30) of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.

- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights, which the purchaser may have against the supplier under the contract.

- GCC16 Payment

16.1 The method and conditions of payment to be made to the supplier under this contract shall be

- GCC18 Contract amendment
- 18.1 No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
- GCC19 Assignment
- 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
- GCC20 Subcontract
- 20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract
- GCC21 Delays in supplier's performance
- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration, and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.

- 21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- 21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.
- 21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

GCC22 Penalties

GCC23 Termination for default

 - 23.1.1 If the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - 23.1.2 If the supplier fails to perform any other obligation(s) under the contract; or
 - 23.1.3 If the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

- If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.
- Any restriction imposed on any person by the Accounting Authority will, at the discretion of the Accounting Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Authority actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
 - 23.6.1 the name and address of the supplier and / or person restricted by the purchaser;
 - 23.6.2 the date of commencement of the restriction
 - 23.6.3 the period of restriction; and
 - 23.6.4 the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

- If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than ten (10) years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. - GCC24 Anti-dumping and countervailing duties and rights
- When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. GCC25 Force Majeure

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event
- GCC26 Termination for insolvency
- The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.
- GCC27 Settlement of disputes
- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5 Notwithstanding any reference to mediation and/or court proceedings herein,
 - 27.5.1 the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - 27.5.2 the purchaser shall pay the supplier any monies due the supplier.
- GCC28 Limitation of liability

- 28.1 Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;
 - 28.1.1 the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
 - 28.1.2 the aggregate liability of the supplier to the purchaser, whether under the contract, in

tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

GCC29 Governing language

29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

GCC30 Applicable law

GCC31 Notices

GCC32 Taxes and duties

ANNEXURE I - ELECTRONIC BID SUBMISSION – GUIDELINE FOR BIDDERS

This document serves the purpose of providing the bidder with guidelines and prescripts on how to submit their bids to the NRF via e-mail.

Conditions for electronic submissions: This section does not apply to soft copies requested on manual submissions. It applies when email submissions are permitted. In circumstances where they are advisable, the business unit needs to ensure that they have appropriate controls and processes in place, such as:⁴

- Valid process of ensuring that bidder's electronic signatures complies with legislation such as The Electronic Communications and Transactions Act, 25 of 2002 (the ECT Act),
- System records exact time and date of submission in a manner that provides appropriate probity to stakeholders such as auditors,
- System to prevent unauthorised access and system to show if infringement,
- System of authorised persons to set / change dates for opening data received,
- System allows simultaneous communication,
- System of record-keeping meets legislative requirements such as The National Archives and Records Service
 of South Africa Act (Act. No. 43 of 1996, as amended).


PRESCRIPTS

- All files must be submitted in pdf format unless otherwise stated.
- Pricing submission (including any SBDs where bidder's price is quoted) must be password protected and submitted as a separate file.
- Two envelope system: All bidders documents must be submitted to the email address specified on the NRF bid document and however the password to the password-protected pricing file must be submitted to a separate email stated in the email specified in the bid document.
- The NRF email size limit is 4MB, bidder must ensure that their submission is no bigger than this limit.
 - o Your files must be Zipped to ensure that your submission is in line with the email size limit
- Timeline for submitting password to NRF
 - The password for pricing file must **not** be submitted before the bid closes.
 - The password may be submitted 1 minute after bid closure and no later than 2 days post bid closure.
 Failure to submit within 2 days may lead to bid being unable to be evaluated thus rendering them unresponsive.
- The subject of your email quote verbatim the bid name in the exact words provided in the NRF bid document.



Converting to pdf

- If you have the desktop version of Microsoft Word, the easiest way to convert your document to PDF is right in Word itself.
- Open the document you want to convert, and then click the "File" tab.



On the backstage screen, select "Save As" from the list on the left.




 On the Save As screen, select where you would like the PDF to be saved (OneDrive, This PC, a particular folder, or wherever).



 Next, click the dropdown arrow on the right side of the "Save as type" box, and select "PDF (*.pdf)" from the dropdown menu.




o If you want to, you can change the filename at this time. When you're ready, click the "Save" button.




 After saving the PDF, you'll be returned to your Word document, and the new PDF will open automatically in your default PDF viewer.

Password protecting files


- To password protect an Office document, first open it in Word, Excel, PowerPoint, or Access. Click the "File" menu at the top-left corner of the screen. On the Info pane, click the "Protect Document" button and select "Encrypt with Password."
- The button is only named "Protect Document" in Microsoft Word, but it's named something similar in other apps. Look for "Protect Workbook" in Microsoft Excel and "Protect Presentation" in Microsoft PowerPoint. In Microsoft Access, you'll just see an "Encrypt with Password" button on the Info tab. The steps will otherwise work the same.
- NOTE: If you only want to restrict editing of the document, you can choose "Restrict Editing" here, but as we said, that is not very secure and can easily be bypassed. You're better off encrypting the entire document, if you can.



- Enter the password you want to encrypt the document with. You'll want to choose a good password here. Weak passwords can be easily guessed by cracking software if someone gains access to the document.
- Warning: You'll lose access to the document if you ever forget your password, so keep it safe!
 Microsoft advises you write down the name of the document and its password and keep it in a safe place.




- When a document is encrypted, you'll see the "A password is required to open this document" message on the Info screen.
- The next time you open the document, you'll see an "Enter password to open file" box. If you don't enter the correct password, you won't be able to view the document at all.




To remove the password protection from a document, click the "Protect Document" button and select "Encrypt with Password" again. Enter a blank password and click "OK." Office will remove the password from the document.

How to Create a Password Protected PDF File


- You can also export an Office document to a PDF file and password protect that PDF file. The PDF document will be encrypted with the password you provide. This works in Microsoft Word but not Excel, for some reason.
- To do this, open the document in Microsoft Word, click the "File" menu button, and select "Export." Click the "Create PDF/XPS" button to export the document as a PDF file.




Click the "Options" button at the bottom of the save dialog window that appears. At the bottom of the options window, enable the "Encrypt the document with a password" option and click "OK."



- Enter the password you want to encrypt the PDF file with and then click "OK."
- When you're done, enter a name for the PDF file and click the "Publish" button. Office will export the document to a password-protected PDF file.
- Warning: You won't be able to view the PDF file if you forget the password. Be sure to keep track of it or you'll lose access to your PDF file.



You'll have to enter the PDF file's password when you open it. For example, if you open the PDF file
in Microsoft Edge–Windows 10's default PDF viewer–you'll be asked to enter the password before
you can view it. This also works in other PDF readers.



Zipping your files.

- o Put all the files into a new folder
- o Right-click on the folder to be sent
- Select "Send To" and then click "Compressed (Zipped) folder"
- The files will start compressing
- After the compression process is complete, attach the compressed file with the extension .zip to your email.

Keeping passwords safe.

We recommend that you store the password either as a note on a hardcopy document which is then filed or stored safely or a softcopy that is saved in the bid response folder once the bid has been submitted or in line with your document management policy.
